MYCO TRAILERS, LLC. EXPRESS LIMITED WARRANTY

MYCO Trailers, LLC. warrants that each MYCO Trailer operated by the original purchaser under normal use will be free from defects in materials and workmanship when employed under normal conditions for the manufactured purpose and provided that the mechanical parts receive proper care as outlined in the owner's manual for a period of one year for components and five years structural (One Year Structural for Government and Commercial) following the original purchase, subject to the requirements, exclusions and limitations stated below which will be strictly applied. Paint finish is warranted for 9 months from date of purchase by original owner or one year from date of manufacturer, excluding damage due to misuse or abrasion.

Exclusion of Components Warranted by Other Manufacturers

Tires, wheels, axles, brake components, lights, winches, rollers, springs, suspension components, couplers, jacks, castors and batteries purchased and installed by MYCO Trailers, LLC. are warranted by their manufacturers and are excluded from this Limited Warranty.

Exclusion of Normal Wear or Maintenance

This warranty does not apply to normal wear or maintenance, (ie). Such as Tires, Brake pads, Bunks, or mechanical parts. Neither does it apply to MYCO steel or aluminum products which have been involved a.) in an accident or subjected to misuse or neglected. B) repaired with parts other than MYCO parts. C.) repaired by other than an authorized MYCO dealer. D.) altered, repaired, or modified outside of warrantor's factory (unless with warrantor's written approval). E.) used in leasing or renting F.) Improperly maintained. G.) Any other causes beyond the warrantor's control.

Transportation costs excluded

Transportation of any trailer to and from your dealer or any approved repair facility shall be the responsibility of the trailer owner. MYCO Trailers, LLC. shall not be liable for any such costs.

Prior Written Consent required and Return of Defective Parts Required

No reimbursement will be made to any dealer or owner for repairs made without the prior written consent of MYCO Trailers, LLC. Any defective parts must be sent prepaid freight to MYCO Trailers, LLC. to qualify for replacement or reimbursement under this Limited Warranty.

How to claim a Warranty

All claims under this warranty must be made through an authorized dealer of MYCO Trailers within the warranty period described above. To obtain warranty service, the owner must return the parts to an authorized dealer with proof of purchase and original ownership (needed to qualify for warranty). The dealer will then request authorization from MYCO Trailers, LLC to return defective parts. MYCO will inspect the parts to determine if repair or replacement is in order. MYCO shall not be responsible for any transportation costs as outlined above.

IMPORTANT – READ CAREFULLY

To the extent permitted by law, the five-year (One Year Government and Commercial) structural limited warranty printed above is the only warranty applicable to this purchase. No other express or implied warranty is given or authorized. All implied warranties, including, but not limited to, the implied warranties of merchantability and fitness for a particular use are disclaimed for any period beyond the above written limited warranty, MYCO Trailers, LLC and the selling dealer shall not be liable for loss of use, loss of time, inconvenience, towing, loss of business or any other consequential or incidental damages.

Some states do not allow limitations on how long an implied warranty lasts or the exclusions or limitations of incidental or consequential damages, so the above limitation or exclusion may not apply to you. The warranty gives you specific legal rights and you may also have other rights which vary from state to state.
